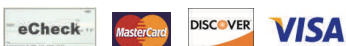

DOG LICENSE APPLICATION

Dog Licenses are required for all dogs kept within Bloomfield. Licenses are due by January 1 each year; the grace period ends on January 31st, regardless of when you dog is vaccinated. State law requires that all dogs be vaccinated against rabies within 30 days of reaching four months of age and that future protection kept current. **Please provide proof of vaccination, complete and sign the affidavit below.**

WINTER PARKING RESTRICTIONS

November 15, 2013 through April 15, 2014



Under Village of Bloomfield Ordinance 7.05 (3) no person shall park a motor vehicle (*except an emergency vehicle*) on or within 5 feet of any roadway, street, highway or public way after a snowfall, in such a manner as to prevent snow plows from removing the snow.

Penalties: **First violation:** *Written warning.*
 Second violation: *Vehicle will be towed and you could be cited with a fine not to exceed \$641.00.*

Please allow room for the Highway Department to clear the streets. Your cooperation will help us make the roads in Bloomfield safe for all the motoring public.
